

# Information for Authors

The *Journal of Information Processing Systems* (JIPS, ISO abbreviation: J Inf Process Syst; eISSN: 2092-805X) is the official international journal of the Korea Information Processing Society (KIPS). It is published bimonthly, on the last day of February, April, June, August, October and December of each year. JIPS is a peer-reviewed journal that publishes high-quality papers on the state of the art of information processing systems and related fields.

The aim of JIPS is to provide an international forum for academic and industrial researchers all over the world to promote, share, and discuss all major research issues and developments in different areas of information processing systems and related fields. This journal publishes theoretical research contributions presenting new techniques, concepts, or analyses, reports on experiences and experiments of implementation and application of theories. Tutorials on recent technologies and trends are also welcome. In addition, featured articles with outstanding contributions and results are selected by the journal's Editorial Board and introduced in the journal homepage. The subjects covered by this journal include, but are not limited to, topics related to (A) computer systems and theory; (B) multimedia systems and graphics; (C) communication systems and security; and (D) information systems and applications. We invite submissions for our upcoming issues that emphasize the independent reproduction of prior work. Additionally, we strongly support the use of open source methodologies and tools, and submissions that leverage these practices will be given special consideration. In order to disseminate the recent technological advancements as quickly as possible, the acceptance of submitted papers will be finally decided according to publication plan. To be accepted, however, a paper must be judged to be truly outstanding in its field and to be of interest to a wide audience.

- **Division A: Computer Systems and Theory** includes computational theory, algorithm theory, grid/clustering computing, middleware, multimedia theory (synchronization, indexing, compacting), parallel/distributed processing theory, and computer systems applications.
- **Division B: Multimedia Systems and Graphics** includes artificial intelligence, image processing, voice processing, natural language processing, multimedia, human-computer interfaces, pattern recognition, computer graphics, the semantic web, and web services.
- **Division C: Communication Systems and Security** includes internet computing, network systems and devices, wireless/ad-hoc/sensor networks, network modeling and simulation, network management techniques, telecommunications, communication protocols, transmission techniques, communication systems, digital rights management, security, encryption and cryptography, compression, and coding.
- **Division D: Information Systems and Applications** includes databases, software engineering, e-commerce, data mining, information retrieval, and computer education.

Manuscripts for submission to the Journal of Information Processing Systems (JIPS) should be prepared according to the following instructions.

## I. COPYRIGHTS AND CREATIVE COMMONS ATTRIBUTION LICENSE

A submitted manuscript, when published, will become the property of the journal. Copyrights of all published materials are owned by KIPS. The Creative Commons Attribution Non-Commercial License (<http://creativecommons.org/licenses/by-nc/3.0/>) is also in effect. The KIPS copyright transfer form is available at <https://jips-k.org/static/submission>.

## II. RESEARCH AND PUBLICATION ETHICS

For the policies on research and publication ethics not stated in this instruction guide, the "Guidelines on Good Publication" (<http://publicationethics.org/resources/guidelines>) apply.

### A. Authorship

Authorship credit should be based on (1) Substantial contributors to the conception or design of the work; or

the acquisition, analysis or interpretation of data for the work; AND (2) Drafting the work or revising it critically for important intellectual content; AND (3) Final approval of the version to be published; AND (4) Agreement to be accountable for all aspects of the work in ensuring that questions related to the accuracy or integrity of any part of the work are appropriately investigated and resolved.

Authors should meet these four conditions after the initial submission of a manuscript, any changes whatsoever in authorship (adding author(s), deleting author(s), or re-arranging the order of authors) must be explained by a letter to the editor from the authors concerned. This letter must be signed by all authors on the paper. The author may be replaced during the review only and will not be allowed once the EiC notifies acceptance of the paper. To correct or replace the author(s): It is possible with the approval by the Committee chairperson when a corresponding author submits his/her request (given form) after obtaining the form from the Editorial Office. (Author replacement or correction is limited to the modification of the authors' order, replacement of corresponding authors, and addition or deletion of authors.) JIPS does not correct authorship after final acceptance unless a mistake has been made by the editorial staff. Authorship may be changed before final acceptance when the authorship correction is requested by all of the authors involved with the manuscript.

The corresponding author takes primary responsibility for communication with the journal during the manuscript submission, peer review, and publication process, and typically ensures all the journal's administrative requirements have been met. The corresponding author should be available throughout the submission and peer review process to respond to editorial queries in a timely manner, and should be available to respond to critiques of the work and cooperate with any requests from the journal for data or additional information or questions about the paper even after publication.

JIPS does not allow multiple corresponding authors for one article. Only one author should correspond with the editorial office and readers for one article. JIPS does accept notice of equal contribution for the first author when the study was clearly performed by co-first authors. There is no limitation on the number of authors.

## **B. Originality and Duplicate Publication**

Submitting the same manuscript to more than one journal concurrently constitutes unethical publishing behavior and is unacceptable.

Submitted manuscripts must not have been previously published or be under consideration for publication elsewhere. No part of the accepted manuscript should be duplicated in any other scientific journal without the permission of the Editorial Board. To avoid any form of plagiarism, each manuscript is checked for similarity against the Similarity Check database using iThenticate software. If duplicate publication related to the papers of this journal is detected, the manuscripts may be rejected, the authors will be announced in the journal, and their institutions will be informed. There will also be penalties for the authors. A letter of permission is required for any and all material that has been published previously. It is the responsibility of the author to request permission from the copyright holder for any material that is being reproduced. This requirement applies to text, figures, and tables.

Self-Plagiarism is defined as a type of plagiarism in which the writer republishes a work in its entirety or reuses portions of a previously written text while authoring a new work. Any allegations of plagiarism or self-plagiarism made to a journal will be investigated by the editor of the journal and JIPS. If the allegations appear to be founded, all named authors of the paper will be contacted and an explanation of the overlapping material will be requested. If the explanation is not satisfactory, the submission will be rejected, and no future submissions may be accepted (at our discretion).

## **C. Conflict of Interest Statement**

The corresponding author must inform the editor of any potential conflicts of interest that could influence the authors' interpretation of the data. Examples of potential conflicts of interest are financial support from or connections to companies, political pressure from interest groups, and academically related issues. In particular, all sources of funding applicable to the study should be explicitly stated.

## **D. Process for Managing Research and Publication Misconduct**

Research misconduct refers to an act that is seriously outside the extent generally accepted by the science and technology field, including fabrication, falsification, plagiarism, unjustified listing of authors, overlapping submissions of paper, duplicate publications, false public statement, interference with investigations of fraudulent acts, and harm to the informant in proposal or performing of research or presentation and reporting of research results.

When the journal faces suspected cases of research and publication misconduct such as redundant (duplicate) publication, plagiarism, fraudulent or fabricated data, changes in authorship, an undisclosed conflict of interest, ethical problems with a submitted manuscript, complaints against editors, and so on, the resolution process will follow the flowchart provided by the Committee on Publication Ethics (<http://publicationethics.org/resources/flowcharts>). The discussion and decision on the suspected cases will be carried out by the Ethics Committee of JIPS.

When an author discovers a significant error or inaccuracy in his/her own published work, it is the author's obligation to promptly notify the journal editor or publisher and cooperate with the editor to withdraw or correct the paper.

### **E. Editorial Responsibilities**

The Editorial Board will continuously work to monitor and safeguard publication ethics: guidelines for retracting articles; maintenance of the integrity of the academic record; preclusion of business needs from compromising intellectual and ethical standards; publishing corrections, clarifications, retractions, and apologies when needed; and excluding plagiarism and fraudulent data.

The editors maintain the following responsibilities: responsibility and authority to reject and accept articles; avoiding any conflict of interest with respect to articles they reject or accept; promoting publication of corrections or retractions when errors are found; and preservation of the anonymity of reviewers. Editors may confer with other editors or reviewers in making this decision.

Editors must respect reviewers' right to confidentiality. Also, editors must not disclose information about manuscripts (including their receipt, content, status in the reviewing process, criticism by reviewers, or ultimate fate) to anyone other than the authors and reviewers.

### **F. Organization and Decisionmaking Procedure of Research Ethics Committee**

The Research Ethics Committee is convened when cases of research ethics violations are reported within the society and is dissolved when the relevant matters are closed. The composition of the committee is as follows:

1. The committee is composed of 5 or more and 10 or less members, and the president is appointed by members of the society.
2. The chairperson is appointed by the president from among the vice-presidents of the society, and vice-chairman and assistant administrators are voted by the committee.

The Research Ethics Committee meeting is held to review the cases of violations of the Research Ethics Regulations and take a disciplinary measure as necessary. It may warn, suspend, or deprive membership of members who are found to have violated the Research Ethics Regulation and notify the decision to the institution or individual.

## **III. QUALIFICATION FOR AUTHORS AND LANGUAGE**

### **A. Qualification for Authors**

Any researcher throughout the world can submit a manuscript if the scope of the manuscript is appropriate.

### **B. Language**

Manuscripts should be submitted in scientific American English.

## **IV. SUBMISSION AND PEER REVIEW PROCESS**

### **A. Submission**

All manuscripts should be submitted online via the journal's online submission system (<https://www.manuscriptlink.com/journals/jips>) by the corresponding author. More detailed instructions are available at the JIPS homepage (<http://jips-k.org>). All articles submitted to the journal must comply with these instructions. Failure to do so will result in return of the manuscript and a possible delay in publication.

All manuscripts that have been published or submitted to other journals or books will not be considered for publication in JIPS. Revised or extended versions of papers printed in conference, workshop, or symposium proceedings may be submitted to this journal with an appropriate cover note.

## B. Peer Review Process

All manuscripts are treated as confidential. They are peer-reviewed by 2 or more reviewers selected by the editor and associate editors. The corresponding author is notified as soon as possible of the editor's decision to accept, reject, or request revision of manuscripts. When the final revised manuscript is completely acceptable according to the JIPS format and criteria, it is scheduled for publication in the next available issue.

The criteria for paper reviewing are as follows:

- How does this manuscript advance the field of research and/or contribute something new to the literature?
- Is this manuscript relevant to the community of readers of JIPS?
- Is the manuscript technically correct?
- Is the paper clearly written and well organized?
- Are all figures and tables appropriately provided and is their resolution in good quality?
- Does the introduction state the objectives of the manuscript, encouraging the reader to read on?
- Are the references relevant and complete? The reviewers should supply missing references.

Submitted papers will be reviewed according to the peer review process. Revisions are usually requested to take account of the referees' comments and critique. Failure to resubmit the revised manuscript within 30 days is regarded as a withdrawal. The corresponding author must indicate clearly what alterations have been made in response to the referees' comments point by point. Acceptable reasons should be given for noncompliance with any recommendation of the referees.

## V. MANUSCRIPT PREPARATION

### A. General Requirements

- All manuscripts must be written in MS Word (not LaTeX), and the sample of the submission format is available at <http://jips-k.org/submission>.
- The paper pages should be consecutively numbered throughout.
- Authors should express all measurements in conventional units, with International System of Units (SI).
- Only standard abbreviations should be used. The use of nonstandard abbreviations can be confusing to readers. Abbreviations should be avoided in the title of the manuscript. Abbreviations should be spelled out when first used in the text—for example, extensible markup language (XML).
- The names and locations (city, state/province [if relevant], and country) of manufacturers should be given.
- Ensure correct use of the terms sex (when reporting biological factors) and gender (identity, psychosocial or cultural factors), and, unless inappropriate, report the sex and/or gender of study participants, the sex of animals or cells, and describe the methods used to determine sex and gender. If the study was done involving an exclusive population, for example in only one sex, authors should justify why, except in obvious cases (e.g., prostate cancer). Authors should define how they determined race or ethnicity and justify their relevance.

### B. Paper Categories

This journal's publication types include original articles and editorials. Other types are also negotiable with the Editorial Board.

#### 1) *Original Article*

There are three types of original articles: Regular track paper and Fast track paper (A, B). The page limit for Regular, Fast Track B Paper, and Fast Track A paper is within 11 and 8, respectively, single-sided pages, including tables and figures. Pages can be added up to 4.

The manuscript for an original article should be organized in the following sequence: front cover, abstract and keywords, main text, acknowledgment, references, and author biographies. The paper pages should be consecutively numbered throughout.

##### (1) Front Cover

The front cover of each manuscript should include a submission area (one of the four "divisions" mentioned above), paper title, list of authors (main author and co-authors), author's affiliation, and corresponding author information.

The front cover file should be attached separately from the main text when submitting the paper. The main text should not contain the authors' names or affiliations to enable blind peer review.

## (2) Abstract and Keywords

The length of the paper abstract should not exceed 250 words. Manuscripts exceeding these guidelines may be returned to the authors. Abbreviations or references are not allowed in the abstract. Up to 6~7 keywords should be listed at the bottom of the abstract to be used as index terms.

## (3) Main Text

Introductory discussion should be kept to a minimum, and material published elsewhere should be referenced, not reproduced. Any material not essential to the continuity of the text should be placed in the Appendices. Formulas must be numbered. Figures (or pictures) and tables, with captions, must be numbered and referred to in the text. Text section headings have three levels with established specifications: primary, secondary, and tertiary. Enumeration of section headings is required. The section headings are as follows:

1. Introduction
2. Related Works (primary)
  - 2.1 Wavelet Filterbank (secondary)
    - 2.1.1 Wavelet theory (tertiary)

References in the reference list must be numbered in the order of occurrence and referred to in the text by bracketed numbers.

## (4) Tables and Figures

Tables are self-explanatory and should not repeat any material from the main article or figures. If the tables or figures are not original, the author should request permission from the relevant copyright holder, and it should be noted in the caption of the tables or figures that permission has been granted.

Figures are numbered consecutively in the sequence mentioned in the text and must have a caption written in the form of a single paragraph. The caption should contain an explanation of all abbreviations and symbols used, and indicate the size value of lines or bars unless shown directly on the figure. The figure number should be placed at the lower-left corner of each figure, and the numbering order must be from left to right, then from upper to lower. Citations of figures in the text or parentheses are abbreviated, e.g., Fig. 1, Figs. 1 and 2, Figs. 1-3, (Fig. 1), (Figs. 1 and 2), (Figs. 1-3). Even if the figures (or pictures) are reduced in size for publication, they should be sufficiently large and clear enough not to be affected by the process.

When the text refers to both figures and tables, they should be mentioned in parentheses, e.g., (Table 1; Fig. 2) and (Tables 1-3; Figs. 4-6).

## (5) List of References

In the text, references should be cited with Arabic numerals in brackets, numbered in the order cited. In the References section, the references should be numbered and listed in order of appearance in the text. The references should only include works that have been published or accepted for publication. Personal communications and unpublished works should only be mentioned in the text. All references in the manuscript must have DOI links. The correct citation format for an article in JIPS is as follows:

### (6) Author Biographies

When submitting to JIPS, authors should include biographical information for each author as well as a black-and-white photograph. Each biography should be one paragraph and should include the author’s ORCID ID, educational background, work experience, current position in affiliation and membership in professional societies.

## 2) Editorial

Editorials are invited by the editor and should be commentaries on articles published recently in the journal.

# VI. FINAL PREPARATION FOR PUBLICATION

## A. Final Version

After the paper has been accepted for publication, the author(s) should submit the final version of the manuscript. The sample of the final-paper format is available at <http://jips-k.org/static/submission>. The names and affiliations of the authors should be double-checked, and if the originally submitted image files were of poor resolution, higher resolution image files should be submitted at this time. Symbols (e.g., circles, triangles, squares), letters (e.g., words, abbreviations), and numbers in figures should be large enough to be legible on reduction to the journal’s column widths. All symbols must be defined in the figure caption. If the symbols are too complex to appear in the caption, they should appear on the illustration itself, within the area of the graph or diagram, not to the side. If references, tables, or figures are moved, added, or deleted during the revision process, they should be renumbered to reflect such changes so that all tables, references, and figures are cited in numeric order.

## B. Manuscript Corrections

Before publication, the manuscript editor will correct the manuscript such that it meets the standard publication

format. The author(s) must respond within 1 week when the manuscript editor contacts the author for revisions. If the response is delayed, the manuscript's publication may be postponed to the next issue.

### C. Galley Proof

The author(s) will receive the final version of the manuscript as a PDF file. Upon receipt, within 2 days, the editorial office (or printing office) must be notified of any errors found in the file. Any errors found after this time are the responsibility of the author(s) and will have to be corrected as an erratum.

## VII. PUBLICATION PAGE CHARGES

There is no submission fee. The article-processing charge for papers accepted for publication is based on the following policy. Authors may select the submission track of their choosing.

- **Regular Track (US \$490 or KRW 490,000)**

1. Additional Fee: KRW 80,000 (US\$80) per page (within 4 pages).
2. Period: It will take average 1~2 years to publish an accepted paper.  
Papers will be processed on the first-accepted first-published basis.
3. Remark: The size must be within 11 pages including a photo and a profile (refer to the sample paper format).
4. Decision: Accept, Minor, Major and Reject

- **Fast Track B (US \$890 or KRW 940,000)**

1. Additional Fee: KRW 100,000 (US\$100) per page (within 4 pages).
2. Period: It will take average 7~8 months to publish an accepted paper.
3. Remark: The size must be within 11 pages including a photo and a profile (refer to the sample paper format).
4. Decision: Accept, Minor, Major and Reject

- **Fast Track A (US \$1,200 or KRW 1,300,000)**

1. Additional Fee: KRW 100,000 (US\$100) per page (within 4 pages).
2. Period: It will take average 4~5 months to publish an accepted paper.
3. Remark
  - a. The size must be within 8 pages including a photo and a profile (refer to the sample paper format).
  - b. It is recommended to use references that are papers published within the last three years.
4. Decision: Accept, Reject and Revision.
